

Natural Gas Service Providers and Their Prices in Nebraska

2006

In 2006, the [residential sector](#) paid an average of \$11.30 per thousand [cubic feet](#) for natural gas, The [commercial sector](#) paid \$9.62, the [industrial sector](#) paid \$8.37, and the [electric power sector](#) paid \$7.31.

The state's natural gas was supplied by nineteen companies whose average 2006 residential rates ranged from Hastings Utilities' \$7.69 to the City of Stromsburg's \$15.74 per thousand cubic feet. Commercial rates ranged from Hastings Utilities' \$8.12 to the City of Stromsburg's \$13.61. Rates for natural gas used by electric utilities ranged from Stuart Gas Company's \$1.66 to City of Wahoo's \$9.97. Industrial rates ranged from the Fremont Department of Utilities' \$7.72 to the Central City Gas Department's \$14.32.
