Natural Gas Service Providers and Their Prices in Nebraska 2009

In 2009, the <u>residential sector</u> paid an average of \$9.34 (including taxes) per thousand <u>cubic feet</u> for natural gas, the <u>commercial sector</u> paid an average of \$7.44, and the <u>industrial sector</u> paid an average of \$6.02. The <u>electric power sector's</u> average price was withheld for the second consecutive year.

The state's natural gas was supplied by twenty companies whose average 2009 residential rates ranged from Hastings Utilities' \$5.60 to the City of Stromsburg's \$14.62 per thousand cubic feet. Commercial rates ranged from Hastings Utilities' \$6.37 to the City of Superior's \$13.41. Rates for natural gas used by electric utilities ranged from Stuart Gas Company's \$4.10 to City of Wahoo's \$12.21. Industrial rates ranged from the Hastings Utilities' \$5.56 to the City of Superior's \$13.10.
